Two Councillors represent the area on Gwynedd Council namely Cllr. Annwen Hughes and Cllr. Gwynfor Owen.

For the first time in 44 years an election was held at a cost of £2,626 to the Community Council to elect a Community Councillor to fill a vacant seat that existed on the Community Council following the resignation of Cllr. Mark Armstrong in September 2023. Cllr. Giles Bentham was duly elected to fill the vacant seat and he signed his Declaration of Acceptance form at the January meeting of the Community Council. Sadly two other Councillors have resigned from the Community Council namely Cllr. Huw Jones in February and Cllr. Emma Howie in March and the process of electing their successors is underway.

Normal meetings of the Council are held monthly except for August at the Old Library in the town on the first Monday of every month apart from May when the meeting is held on the second Monday because of the bank holiday.

EXTERNAL MEMBERSHIP

The Community Council is a member of One Voice Wales, which is the main representative body for Community and Town councils in Wales. The Community Council elects Members to other external bodies, namely, Old Library Committee, Memorial Hall Committee and the Governing Body of Ysgol Tan y Castell.

ACCOUNTABILITY

The Community Council has adopted a Member's Code of Conduct and a register of interests is kept for each member. Each Councillor has to declare any interest they have in items to be discussed at the start of each meeting and these are noted in the minutes. The Community Council is audited by internal and external auditors annually. The internal audit is undertaken by the Audit Department of Gwynedd Council and the External Audit by the Wales Audit Office.

FINANCE AND EXPENDITURE

The Community Council sets a budget annually and monitors expenditure against budget throughout the financial year by receiving a regular report from the Clerk. The main source of income for the Community Council is the precept which is set annually and presented to Gwynedd Council in January for the following financial year. The precept is collected on behalf of the Community Council by Gwynedd Council and is the only source of tax revenue available to Town and Community Councils. The process of deciding on the level of precept includes the preparation of a draft budget on the basis of the financial situation of the Community Council by considering the likely costs, plans for projects, setting an amount for contributions - within the

guidelines published annually - and any other financial matters. Consideration is also given to the reserves held by the Community Council to ensure an appropriate precept is set. The level of precept was kept at £70,000 for 2023/24. In addition, the Community Council received £7,056.71 from the 10% Parking Scheme by Gwynedd Council which it joined a few years ago.

BUDGET

The Council's precept is £70,000 and is earmarked as follows:-

Donates £10,000 to Gwynedd Council to keep the public toilets open (the one in Bron y Graig Isaf car park and the one near the Queens hotel are open all year round and the one in Min y Don car park is open for 6 months of the year)

Also donated £21,000.00 in this financial year to Harlech and Ardudwy Leisure (HAL) to keep the swimming pool open.

To date the Council has spent £1,177.90 on maintaining the public toilets near the Memorial Hall, and also the Council has paid the caretaker £1,430.23 for cleaning these toilets on a daily basis. The Council is closing these toilets over the winter season so they can carry out more maintenance work on them.

The Council spent £26,982.00 on new play equipment in the King George V playing field and also £900 to create a disabled friendly user path from the road to the play area. This expenditure on the playground was above what was budgeted for originally, but the Members agreed that this work had to be carried out as many members of the public were complaining that there was not enough play equipment in the King George V playground to keep youngsters entertained and off the street.

The Council spends a substantial sum to cut the grass in the public cemetery, LLyn y Felin play park and King George V play park regularly

every two weeks between April and October. Also the grass on various public footpaths in the area are cut at least twice a year. The cost of all this work in this financial year was £5,919. The Council also spent £3,260 as expenditure for opening graves in the public cemetery.

The Council donates to various organizations in the area annually at their monthly meetings in October and March and have contributed £3,000 To Friends of Tan y Castell School, £2,000 to the local Cylch Meithrin and £650 towards the purchase of two Blue Plaques to commemorate well known people who lived in the town. £2,000 each annually is contributed to the running of the Memorial Hall and the Old Library due to the Community Council been Trustees of both these organizations. These contributions are included in the Council's precept.

This year the Council have contributed £1,200 towards the christmas lights in the town and £1,610 for the annual Mop Fair to be held in the town.

Unfortunately in December 2022 the Council was financially defrauded out of £9,000 by a person claiming to be going to carry out consultancy work. This matter, at the moment, is under investigation by the Financial Ombudsman and their outcome is still awaited.

On the 7th November the Council received a report in the public interest to Harlech Community Council. The report reflected on comments that was received by Audit Wales in response to our consideration document. The Auditor General issued this report under powers granted by section 22 of the Public Audit (Wales) Act 2004. A copy of the report was published on Audit Wales's website on the 8th of November 2023.
